1. <u>2023-019 Conditional Use Permit for Steven Vanderlick dba Mach One Towing:</u> The applicant is requesting approval of a Conditional Use Permit (CUP) to operate a tow yard at 3293 Highway 12 in Burson. The use is proposed on an approximately one-acre area in the front of the parcel, north of the existing office, for towing, storage, and roadside services. The subject parcel, APN 048-016-003, is a portion of Section 20, T04N, R10E, MDM. Pursuant to CEQA guidelines, a Notice of Exemption has been prepared for this project. 2. <u>2023-048 Appeal of Staff Decision</u> The applicant is appealing a staff decision to not provide zoning clearance to build two movable storage sheds on a vacant, undeveloped RR-zoned parcel without establishing the primary residential use required by Section 17.22.010 of the Calaveras County Code. Per Section 17.98.020 of the Calaveras County Code, a decision of any staff member may be appealed to the Planning Commission. The subject property is a 19.98-acre parcel, Zoned Rural Residential, located at 3559 Stagecoach Road, in Copperopolis California. APN: 054-004-041 is a portion of Section 5, T01N, R12E.
